

 Trust whall be at Annigeri, Tq: Navalgund, Dist: Dharwad, and/ or such other placesas
 the Trustees may determise.
 - The objects of the Trust shall be: EDUCATION: Without prejudice to the generality of such object.
 - To establish, maintain, run, develop, improve, extend, grant, donate for the aid in the establishment, maintenance, improvement and extension of Schools, Colleges and other educational institutions including Medical, technical, Vocational Training Rearch Centers, and Hospitals for Students pursuing their studies.
 - To institute Studentships, Scholarships, Stipends, Medals, Prizes etc. to held and encourage deserving students and provide monetary aid to students scholars and teachers for pursuing their education.
 - To establish, maintain, develop and donate for the establishment, maintenance and development of Book Banks, Libraries, and research units for the advancement and promotion of education.



i) To employ clerks and other employees, Agents, Bankers, Lawyers, Accountants and others on such remuneration as they may fit.

ii) To delegate any powers as they can lawfully delegate to any other person and to ecute such power as they may think fit for the purpose.

iii) To convert, call in, sell or otherwise, dispose of any of the investments comprised in the Trust Property and reinvest or change the nature of any other investments.

iv) The funds of the Trust shall be invested in the modes specified under the provision of Section 03(1)(d) read with 11(5) of the I.T.Act,1961 as amended from time to time.

- v) To withdraw any power or revoke any appointment of any employee or attorney.
- vi) To sell any immovable property belonging to the Trust for the purpose of investing the proceeds in any other property required for the objects of the Trust.
- vii) To let any portion of any immovable property forming part of the Trust Fund, at such rent and for such period and on such terms and conditions as they may think fit and accept surrender of any lease.
- viii) To maintain Bank accounts in the name of the Trust and President to operate the said Account.
- ix) To appoint proxy or proxies for voting at any meeting of creditors, contributors, contributories, shareholders or otherwise.
- x) To raise loans on the mortgage of the Trust properties movable or immovable with the consent of the President.
- xi) To borrow funds with or without security of the property and for this to mortgage charge and encumber any asset immovable or movable.
- xii) To accept gifts, donations or contributions in so far as they are not inconsistent with the objects of the Trust and all such gifts, donations and contributions shall form part of the corpus of the trust, unless it is otherwise specifically given in writing by the Donor.
 - xiii) To establish Trusts and other institutions having objects similar to those of the Trust.

 Provided further that any or all these powers can be exercised by any trustee or any

 Group of them on being so authorised by the BOARD OF TRUSTEES.
- 10. These powers of the Trustees will be so exercised as to ensure that the income of the Trust would be exempt either under section 10(22) of the Income Tax Act,1961, as existing or as may be



amended from time to time or under any other amended provision of that Act as may be applicable. It is clarified that the power including those mentioned in Clause 9(iv) shall be exercised in such a manner that by reason of the investment of the trust funds or its activities the Trust shall not be construed as existing for purposes of profit within the meaning of the terms under section 10(22) of the Income Tax Act 1961 or any other similar amended provision as will be applicable.



- 11. The Trustees shall maintain all accounts of the Trust regularly. The accounts shall be duly audited by a Chartered Accountant. Every year, the account shall be closed by 31st March.
- 12. The Trustees shall at all time stand indemnified in respect of any Act that may have been bonafide done in respect of matters relating to the Trust, but they shall not be entitled to any remuneration.
- 13. Any decision taken by majority of the Trustees including the President, at any trust meeting, shall be valid and binding on all the trustees and powers so vested in or exercisable by the trustees shall be valid and binding on the trust.
- 14. A minutes book shall be maintained at the office by the Board of Trustees. Minutes of all meetings, appointment and entry into the office of every new trustees and all other proceedings of the Board of the Trustees shall be entered and recorded in such minutes book and shall be signed by he President of the meetings either at the conclusion thereof or at subsequent meting when they re duly confirmed
- 1.5. The President shall at all times during his continuance in the office, have right to delegate his powers to any of the remaining trustees or to other attorneys or agents, with the prior consent of the Board of Trustees.
- 16. The funds and income of the Trust shall be solely utilized for the achievement of its objects and no portion of it shall be utilized for payment of the Trustees/Members by way of profit, interest, dividends etc.
- 17. No amendments to the Trust/Memorandum of Association/Bye-Laws/Rules and regulations shall be made which may prove to be repugnant to the provisions of section 2(15), 11,12 and 13 and 80G of the LT.Act,1961 as amended from time to time. Further no amendment shall be carried out without the prior approval of the Commissioner of Income-Tax.
- 18. In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees/Members of the Managing Committee/ Government Body but the same shall be transferred to another Charitable Trust whose objects are similar to those of this Trust and which enjoys recognition under whose objects are similar to those of this Trust and which enjoys recognition under Section 80G of the I.T.Act, 1961 as amended from time to time.




